National FFA Updates:

1. Give the Gift of Blue Gifts 6,000 Jacket

Last month, the 6,000 jacket was gifted to a young lady in Springfield, Minnesota, as part of our Give the Gift of Blue program. Since Jan. 1, more than 870 jackets have been gifted. Below is the essay from the recipient.

"This is my first year in FFA, and I already can see how it has impacted my life and given me many opportunities and life lessons. Getting this jacket would mean a lot to me. Having my own jacket with my name on it would be fantastic. I like to say that FFA is a pretty big deal around where I live, so it's important for me to represent my town and my school. I would feel like I'm a part of something great, something bigger than anything I've ever been a part of before. I would like to take it to events like national convention and state convention, but also smaller things like contests. I'm on two CDE teams and I have to use the jacket very often. I will be going to state for BIG and I also hope to go for dairy cattle, so having my jacket would help me a great deal. I'd be so happy to own my own jacket like my other classmates. It would be so much easier than borrowing someone else's jacket every time I need it. I'm the first girl in my family that has joined FFA and it would prove a lot to have my own jacket. 2. 212° & 360° Conferences

Conferences are wrapping up for the 212° & 360° 2017-18 conference season, with the last one scheduled for June. Final participation numbers for 212° & 360°, including estimates for the final conference, are more than 9,000 students. This is a 16 percent increase from last year's participation numbers.

5. National FFA Convention & Expo Survey

This week, the convention and events management team sent out a survey to our states and advisors asking for their feedback in regards to purchasing convention concert tickets. It is important that we make this process a seamless and positive experience. The survey will take less than five minutes and will be open through

Wednesday, April 18. All state staff should have received an email about the survey from Mandy Hazlett on Wednesday. Please encourage your chapter advisors to take the survey; their feedback is vital.

6. Find a Living to Serve Grantee Near You

The Living to Serve (LTS) team is pleased to announce that the 2017-18 Living to Serve Grant Projects map is posted and ready to use. You may access the map at FFA.org/LivingToServe.

The interactive map allows users to search by the type of LTS project (yearlong, semester-long, Day of Service Mini-Grant or State Day of Service) as well as the focus area being addressed through the service activities (Hunger, Health and Nutrition; Environmental Responsibility; Community Engagement; and Community Safety). 7. New Grants to Grow Alumni and Supporters

Give Back to Your Roots Grants, sponsored by Crop Production Services, and Legacy Grants, sponsored by Tractor Supply Company, can be used to create an FFA Alumni and Supporters Chapter, to improve the quality of existing chapters or to provide more opportunities for partnership between FFA chapters and alumni and supporters chapters. 2018 grants will be awarded after the last two grant deadlines: June 1 and Sept. 4. Grant applications are located at FFA.org/alumnigrants.

In addition, the March 2018 legacy grant recipients have been selected. See the list of recipients at <u>FFA.org/alumnigrants</u>. The alumni and supporters division handed out 16 grants in 15 states this period.

8. #NextGenAg in the Farm Bill

On Thursday, Mike Conaway (R-Texas), chairman of the House Committee on Agriculture, introduced H.R. 2, the Agriculture and Nutrition Act – better known as the 2018 Farm Bill. The 2014 Farm Bill expires in September, so the Farm Bill's introduction has been widely anticipated among farmers, ranchers, producers, agriculture businesses, schools, and, especially, FFA members.

According to the National Institute of Food and Agriculture at the U.S. Department of Agriculture (USDA), there will be 58,000 U.S. agricultural jobs available annually in the next five years but a shortfall of 23,000 new professionals pursuing those careers. FFA members are motivated to encourage more of their peers to pursue production agriculture and other unique careers in the business, science, and technology of agriculture. On National Ag Day in March 2017, National FFA and 82 other agricultural groups penned a letter to Congress to support the next generation of agriculture through the creation of an agricultural youth coordinator, stationed at USDA. Their advocacy efforts did not stop there, however. State FFA officers in six states attended listening sessions across the country to make this ask to members of the House Committee on Agriculture and their staffs. They educated members of Congress on this issue at the 2017 State Presidents' Conference; made it their objective again at this year's National Ag Day in Washington, D.C.; and have joined in on the #NextGenAg movement on social media.

We all know it's hard to tell students, "No." The House version of the Farm Bill includes an agricultural youth organization coordinator in the text they released this week:

"SEC. 11204. AGRICULTURAL YOUTH ORGANIZATION COORDINATOR.

Subtitle A of the Department of Agriculture Reorganization Act of 1994 is amended by inserting after section 220 (7 U.S.C. 6920) the following new section:

- "SEC. 221. AGRICULTURAL YOUTH ORGANIZATION COORDINATOR.
- "(a) AUTHORIZATION.—The Secretary shall establish in the Department the position of Agricultural Youth Organization Coordinator.
- "(b) DUTIES.—The Agricultural Youth Organization Coordinator shall—
- "(1) promote the role of youth-serving organizations and school-based agricultural education in motivating and preparing young people to pursue careers in the agriculture, food, and natural resources systems;
- "(2) work to help build awareness of the reach and importance of agriculture, across a diversity of fields and disciplines;
- "(3) identify short-term and long-term interests of the Department and provide opportunities, resources, input, and coordination with programs and agencies of the Department to youth-serving organizations and school-based agricultural education, including the development of internship opportunities;
- "(4) share, internally and externally, the extent to which active steps are being taken to encourage collaboration with, and support of, youth-serving organizations and school-based agricultural education;
- "(5) provide information to young farmers concerning the availability of, and eligibility requirements for, participation in agricultural programs, with particular emphasis on beginning farmer and rancher programs;
- "(6) serve as a resource for assisting young farmers in applying for participation in agricultural

programs; and

- "(7) advocate on behalf of young farmers in interactions with employees of the Department.
- "(c) CONTRACTS AND COOPERATIVE AGREEMENTS.
- —For purposes of carrying out the duties under subsection (b), the Agricultural Youth Organization Coordinator shall consult with the cooperative extension and the land-grant university systems, and may enter into contracts or cooperative agreements with the research centers of the Agricultural Research Service, cooperative extension and the land-grant university systems, non-land-grant colleges of agriculture, or nonprofit organizations for—
- "(1) the conduct of regional research on the profitability of small farms;
- "(2) the development of educational materials;
- "(3) the conduct of workshops, courses, and certified vocational training;
- "(4) the conduct of mentoring activities; or
- "(5) the provision of internship opportunities."

The Farm Bill is expected to be marked up in committee next week, and we will continue to monitor it and this provision.
